SECRETARY'S REPORT

Minutes

TREASURER'S REPORT

LANDSCAPE REPORT

Upon review, a motion was made, seconded, and unanimously carried to approve the following proposals from Hacienda Landscape,

- Install fencing and signs to deter bicycle riders from creating jumps and damaging the common area at the cost not to exceed \$1,630.00. This includes installation of 4 signs and temporary fencing.
- Install two pest waste stations on Rancho Cielo at Via de La Luz and Rancho Cielo at La Nubes at the agreed cost of \$2,400.00 which shall be funded from the reserve account, GL 3030 Contingency Reserves.

Drainage Behind 32056 and 32052 Camino del Cielo

Upon review of the documentation from the affected owners, the board agreed to install a French drain behind 32506 and connect it to the drain at 32052, then add gravel to the trench dugout by the owner of 32052 to keep it from filling with dirt. Management will obtain costs from the landscaper and poll the board for approval so the project can commence immediately.

GENERAL MATTERS

New Parking Patrol Service

The board discussed continuing with the new parking patrol service and asked management to have the owner attend the March meeting for a meet and greet.

Street Sign Project

The board reviewed and discussed new street sign options presented by All Sign Concepts.

Management was asked to obtain mock-ups of the signs for each street name and to see how certain names would have to be abbreviated to fit on the sign.

Annual Garage Sale

The board reviewed and approved the annual garage sale put on by Alan Neilson with Century 21 which is set for Saturday, May 18, 2023, from 7:00 to 10:00 am.
