The board reviewed the proposal presented by All Sign Concepts for removal and replacement of all street signs with new "scroll" mounting brackets. Management was asked to obtain a competitive proposal for the next meeting.

Gate Attendant Contract

A motion was made, seconded, and unanimously carried to approve the gate attendant service contract provided by Titanium USA at the agreed cost of \$169,936.00 annually, effective May 1, 2024.

Member Requests

The board reviewed a request from an owner regarding the eucalyptus trees in the neighborhood being a fire hazard and would like them all to be removed. The association's insurance agent weighed in on the request from an insurance perspective and indicated that Insurance companies routinely ask insureds to trim trees away from homes, but only when they're touching the structure, not based on type. Also, regarding fire maps, they do not consider the amount, or type of trees in the neighborhood, they are more focused on brush, slope of land and wind patterns.
