#### Location:

## Call to Order:

#### Homeowners Discussion

Mr. Alosio, the owner of 32031 Lomita was present at the meeting and asked the Board to reverse fines from his account that were assessed against the previous owner. The Board approved the request.

The Board reviewed an e-mail from Mr. Barakat, the owner of 21802 Via del Lago in which he was asking for adjustments to his account. The matter was discussed in closed session.

The Board reviewed a series of e-mails from and to Mrs. Hoopes, the owner of 31785 Via del Viento in which she was writing to address privacy issues behind her home that she felt were created as a result of the front gate project. The Board noted they would consider adding more plant material in the area but would not reinstall a fence in the area. It was noted they original fence did not provide security to the homes in the area and that it was completely rotted and had to be removed.

The Board reviewed e-mails from Mr. Stone, the owner of 21812 Via del Lago in reference to the front entry gates. It was noted that Mr. Miller had contacted Mr. Stone and addressed his questions.

The Board received a letter from Mr. Ryan, the owner of 21842 Via del Lago. Due to the nature of the letter, the Board addressed the matter in closed session.
