#### Fall Maintenance Reminders

With Fall quickly approaching, it is time to consider some basic maintenance items that can help protect your family and save you money. Some of the items to consider are:

- 1. Change the batteries in your smoke detectors.
- 2. Cut back the time and frequency of your irrigation water.
- 3. Replace the filters for your heating system.
- 4. Check the water supply lines for your appliances and plumbing fixture. (Use the steel braided hoses)
- 5. Trim your overgrown trees.

## Street Sweeper

The association streets are swept each **Thursday**. Please make sure your vehicles are not parked on the street. Also, if you have been performing maintenance at your home that has resulted in an accumulation of debris and dirt, please make sure that you or your contractor removes the debris from the street. The excessive debris often creates a huge mess.

### Approved Vinyl Fencing
