A Brief History of Veterans Day

"Veterans Day, formerly known as Armistice Day, was originally set as a U.S. legal holiday to honor the end of World War I, which officially took place on November 11, 1918. In legislation that was passed in 1938, November 11 was "dedicated to the cause of world peace and to be hereafter celebrated and known as 'Armistice Day.'" As such, this new legal holiday honored World War I veterans.

In 1954, after having been through both World War II and the Korean War, the 83rd U.S. Congress -- at the urging of the veterans service organizations -- amended the Act of 1938 by striking out the word "Armistice" and inserting the word "Veterans." With the approval of this legislation on June 1, 1954, Nov. 11 became a day to honor American veterans of all wars.

In 1968, the Uniforms Holiday Bill ensured three-day weekends for federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. Under this bill, Veterans Day was moved to the fourth Monday of October. Many states did not agree with this decision and continued to celebrate the holiday on its original date. The first Veterans Day under the new law was observed with much confusion on Oct. 25. 1971.

Finally on September 20, 1975, President Gerald R. Ford signed a law which returned the annual observance of Veterans Day to its original date of Nov. 11, beginning in 1978. Since then, the Veterans Day holiday has been observed on Nov. 11."

This led to daylight saving time (DST), which was introduced in 1966 as part of the Uniform Time Act. The law was an effort to preserve the daylight, according to the U.S. DOT. The department keeps a list of reasons on the positives for turning the clock back, including saving energy, preventing traffic injuries, and claim the time change even prevents crime."

POOL RULES

- 1. Children under the age of 14 must be accompanied or supervised by an adult over the age of 18.
- 2. Swimming pool and jacuzzi hours are from Thursday to Sunday 6 AM to 11 PM, and Friday and Saturday from 6 AM to 12 AM.
- 3. Personal items (towels, chairs, etc.) are not to be left in the pool area overnight.
- 4. Hairpins or metal clips are not allowed in the pool, as they will clog the drains and filters. For the same reason, hair longer than shoulder length must be tied back with a rubber band or a swimming cap must be used.
- 5. Playing with the safety equipment is in violation of the Department of Health and will not be allowed.
- 6. No pets of any kind will be allowed in the pool area.
- 7. No bicycles, skateboard, roller skates, frisbees, boogie boards, etc. are not allowed in the pool area.
- 8. Food or drinks are to be kept at least 3 feet from the pool or spa.
- 9. NO GLASS or other breakable objects are allowed in the pool area.
- 10. The pool area is for the sole use of Rancho Cielo Homeowners and their guests.
- 11. Guests must be accompanied by the resident.
- 12. Pump room area is off-limits.
- 13. The pool gate and restroom doors must remain locked at all times. They are NEVER to be propped open.
- 14. When leaving the pool area, trash must be placed in the containers, furniture put back.
