FALL IS FAST APPROACHING!

DROUGHT STATUS UPDATE:

Voluntary three-days-per-week watering April through October for lawn or landscaped areas using drinking water; and one-day-per-week November through March. Targeted outreach to HOAs and other irrigation customers using drinking water regarding conservation measures to be enforced in deeper WSCP levels, if necessary. Requirement to fix leaks or breaks in their systems within 48 hours of notification by the District. Encouraging best practices for recreational water features such as pools and spas (included in WSCP) TCWD has activated its Water Shortage Contingency Plan (WSCP) Level 2 which targets water use reductions equivalent to approximately 20%
